UNISON City of Edinburgh condemns the decision of the council administration to support a Liberal Democrat budget that among other things calls for the privatisation of waste services and for the removal of the No Compulsory Pledge at a full council meeting held on Thursday 23 February 2023.

"Back in 2012 our branch ran the successful 'Our City's Not For Sale' campaign and along with the support of the city's community groups we prevented the privatisation of several council services."

UNISON is again preparing to campaign to say, 'Our City's still Not for Sale' and is calling on the administration and all other councillors to 'Keep Edinburgh Public' and honour the pledges that got them elected.

UNISON has had initial communication with members' of the

administration to highlight our opposition to the decision taken. We will be holding further meetings with them and other elected members of all political parties to make sure our members voices are heard in any proposed changes. Your branch officers will continue to challenge the Administration on the impacts of these budget decisions and ensure that any proposals to fast tract the budget recommendations are vociferously opposed and not implemented at future full council meetings.

The administration must 'Keep Edinburgh Public' and respect the pledges that got them elected.

If the administration does not engage positively with our demands, we will reiterate current branch policy to use all the means at our disposal up to and including industrial action to prevent any compulsory redundancies and restart Our City is still Not For Sale campaign to prevent any outsourcing or privatisation of council services.

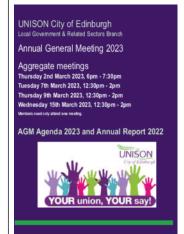
